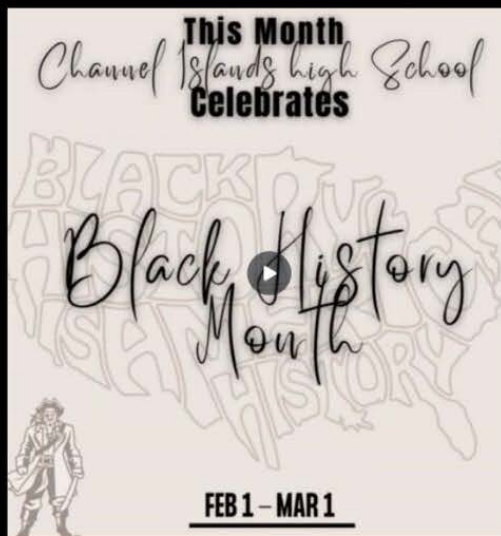
Admin Update
